After the unexpected death of IFPB's bookkeeper in 2016, a careful review of IFPB's books revealed several instances of uncleared checks and small journal entry lines in error in two previous years. Primarily, these were small entries attempting to track payroll tax, but that actually duplicated other cleared and reconciled expenses. To correct the books we have voided and removed these transaction.

Overall, these discrepancies account for \$1,458 total in prior period adjustments, consisting of \$554 in errors in tax year 2013 and \$904 in tax year 2014.
