AIFD's public engagement projects include numerous media appearances, publications, and public forums The landmark events that have occurred in the Middle East in 2011 increased AIFD's public presence as a subject matter expert Our public engagement program has increased our media opportunities at a sustained and exponential rate with almost five times the number of media appearances in 2011 than in 2009 AIFD has reached an estimated audience size of almost 339 million people through its media efforts which equates to a media impression level of almost 847 million people Our participation in government, university, and think tank roundtables have doubled from 2010 to 2011 AIFD's writings have been published by a variety of national leading publications Our office has also responded to thousands of phone calls, emails, and postings from people across the country

The American Islamic Leadership Coalition (AILC) is a collaborative project of diverse American Muslim leaders AILC's mission is dedicated to defending the US Constitution, upholding religious pluralism, protecting American security, and chenshing diversity in the practice of Islam AILC continues to gain momentum in its work as each leader publicizes their individual work and the coalition comes together to serve as an alternative to the domestic and global network of Islamist organizations such as the Council on American-Islamic Relations, Islamic Society of North America, and the Muslim Public Affairs Council We continue to seek out other like-minded Muslim leaders to join in our fight for Muslim reform After the House Committee on Homeland Security's hearings on March 10, 2011, the coalition grew from six to over 20 American Muslim members from North America
