 AIFD's public engagement project seeks to inform the public on the ideological battle taking place within the House of Islam between modern Muslims who embrace the separation of government from faith and Islamists who believe in the supremacy of the national Islamic state In 2012, our program generated over 900 media opportunities since mid-2009 AIFD reached an estimated audience size of almost 339 million people through our media outreach efforts which equates to a media impression level of almost 847 million people AIFD testified before Congress as leading experts on key related issues to our mission with regards to Syria, Egypt, religious liberty, anti-Semitism, and Muslim radicalization to name a few Our participation in government, university, and think tank roundtables doubled from 2011 to 2012 AIFD opinions have been published by a variety of leading print and online publications Our office has also responded to thousands of phone calls, emails, and postings from people across the U S

 The American Islamic Leadership Coalition (AILC) is a collaborative project of diverse American Muslim leaders AILC's mission is dedicated to defending the US Constitution, upholding religious pluralism, protecting American security, and chenshing diversity in the practice of Islam AILC continues to gain momentum in its work as each leader publicizes their individual work and the coalition comes together to serve as an alternative to the domestic and global network of Islamist organizations such as the Council on American-Islamic Relations, Islamic Society of North America, and the Muslim Public Affairs Council We continue to seek out other like-minded Muslim leaders to join in our fight for Muslim reform After the House Committee on Homeland Security's hearings on March 10, 2011, the coalition grew from six to over 25 American Muslim members from North America in 2012
