The American Islamic Leadership Coalition (AILC) is a collaborative project of diverse American Muslim leaders AILC's mission is dedicated to defending the US Constitution, upholding religious pluralism, protecting American security, and chenshing diversity in the practice of Islam AILC continues to gain momentum in its work as each leader publicizes their individual work and the coalition comes together to serve as an alternative to the domestic and global network of Islamist organizations such as the Council on American-Islamic Relations, Islamic Society of North America, and the Muslim Public Affairs Council We continue to seek out other like-minded Muslim leaders to join in our fight for Muslim reform The growing AILC continues to cooperate in meetings, papers, public position statements, and media appearances, in the promotion of our ideas for Muslim reform against Islamism and to aid public counterterrorism efforts against radical Islamists Currently the coalition is planning a large (200+ member) conference of like-minded Muslims, which will result in concrete policy recommendations, publications, and networking
