<p>28</p> <p>AIFD's program services continue to grow and increase in engagements. Programming includes three major programs: 1) Public Engagement - general public education on the threat of Islamism (political Islam) and its role in Muslim radicalization and increasing threats to Americans domestically and abroad; 2) Muslim Liberty Project (MLP) - youth and young adult engagement on American and western national identity, ideas, and liberty as an alternative to Islamist movements; and 3) Muslim Reform Movement (MRM) - a coalition of diverse western reform-minded Muslim leaders and organizations that stand for liberty and against Islamism. Our Public Engagement project continues to grow including hundreds of local and national media appearances, publications, and public forums as well as a heavy programming emphasis on social media engagement on the web, twitter, Facebook, YouTube, and other platforms. AIFD has participated in numerous forums and platforms in 2018 in government (i.e. testimony to Congress as well as briefing for various branches of government in the executive and legislative branches), universities, interfaith work, and other media. The need for AIFDs work continues to grow exponentially with global challenges related to Islamist radicalization and spread of jihadist ideologies. Additionally, the instability in regions most notably in Syria, Iran, Saudi Arabia, Pakistan and across major Muslim majority nations has solidified AIFD's public role as a subject matter expert. AIFD is sought after by public policy experts, governments, and universities, as well as domestic and foreign community networks for its expertise in national security, religious freedom, political Islam, Islamist terrorism and associated domestic and foreign policy. AIFD's office has also responded to thousands of phone calls, emails, and postings from people across the country with networking across the world. In 2018, AIFD's most notable public forums included testimony before The House Committee on Oversight and Government Reform, Subcommittee on National Security in July on the need to designate the Muslim Brotherhood a foreign terrorist organization (FTO). AIFD participated in a large town hall in Oklahoma City in March 2018, the Security Summit in Salt Lake City, Utah in March 2018, as well as a host of university forums in the spring of 2018, a debate in New York City about the horrors of Female Genital Mutilation in May 2018 as well as attending a summit on Countering Islamism in Washington, DC in September 2018 among many other programs.</p> <p>(Grants \$ 63,370)</p>	28a		<input type="checkbox"/>

<p>29 AIFD has continued to lead diverse American and western Muslim leaders in establishing a voice for reform and against Islamism. In December 2015, the Muslim Reform Movement (MRM) was convened by AIFD and has since been maintained for the most part through AIFD leadership and programming. The MRM has used its joint declaration as a reform tool (platform) for its member organizations. The MRM now includes over 30 leaders and organizations with diverse voices in the United States, Canada, and Europe who are dedicated to reform. These networks of reform-minded Muslim leaders continue to gain momentum in their work as each leader publicizes and advocates their individual work and the collective then comes together to serve as an alternative to the domestic and global network of Islamist organizations such as the Council on American-Islamic Relations, Islamic Society of North America, and the Muslim Public Affairs Council. We continue to seek out and add other like-minded Muslim leaders across the world to join in our fight for Muslim reform towards modernity. The growing network of diverse leaders, led by AIFD, continues to cooperate in monthly meetings, joint papers, public position statements, and hundreds of media appearances and public forums, in the promotion of our ideas for Muslim reform against Islamism and to aid public counterterrorism and counter radicalization efforts against radical Islamists. We seek through our public platforms to shift the whole of society's approach in counterterrorism from the currently ineffective Countering Violent Extremism (CVE) strategy to a more strategic Countering Violent Islamism (CVI) programming and strategy.
